## Public Performance Rights License

Agreement between Kino Lorber Educational (hereinafter "Kino Lorber") and Institution, named on the front side of the Order Confirmation and Invoice (hereinafter referred to as "Licensor"), stating the terms that govern the use of the Public Performance Rights license, wherein Kino Lorber grants Licensor and Licensor accepts from Kino Lorber the limited license to offer the Program(s) **WEDDING IN GALILEE** in accordance with the following Terms and Conditions. Licensor agrees to these Terms and Conditions by accepting delivery of any Program. Licensor acknowledges that the Program(s) may not be utilized in any manner other than as specified herein and in no event shall: the Programs be exhibited to an admission paying audience without the specific permission of Kino Lorber; nor may any fundraising use of the Programs be made without previous authorization from Kino Lorber. Licensor acknowledges that the Program(s) may not be digitized or transferred to any other medium or format, broadcast, transmitted by cable, or otherwise transmitted, on any multi-receiver or closed circuit system, unless otherwise specified herein or agreed to by Kino Lorber in writing. Nothing herein shall derogate from any rights of Kino Lorber of the Program(s) under the United States copyright law.

1. **RIGHTS** Licensor is hereby granted the right to exhibit the Program(s) to no more than fifty (50) viewers where all viewers, projection monitor, or playback device are all in the same room. The exhibition shall not be publicly advertised nor shall admission be charged.
2. **TERM** The Term of the License is for the life of the DVD and shall commence on the date of Purchase.
3. **PURCHASE** "Purchase" shall mean the release of the Programs by Kino Lorber to Licensor for use during the life of the exact DVD. This License does not apply to additional copies purchased unless specifically granted in writing by Kino Lorber.
4. **PAYMENTS** Licensor shall pay to Kino Lorber within thirty (30) days of shipping the Program(s). Payment shall be made to Kino Lorber Education by check or electronically.
5. **REPLACEMENTS** Kino Lorber shall replace DVDs with proof of purchase of the Public Performance Rights license for damage due to normal wear and tear within the first seven (7) years.
6. **WARRANTIES OR REMEDIES** Kino Lorber warrants that each Program(s) shall be free from defects in material and workmanship at the time of delivery. In the event of breach Kino Lorber's breach of such warranty, or Licensor's dissatisfaction with the Program's content, Licensor's exclusive remedies shall be that Kino Lorber will replace the defective or unwanted Program(s) for different Program(s) that are equal in purchase price, provided Licensor returns said defective or unwanted Program(s) to Kino Lorber. No other warranty, expressed or implied, including a warranty of merchantability, shall apply to any Program hereunder. Kino Lorber shall have no other liability and Licensor shall have no other remedy except as specifically provided in this paragraph; and in no event shall Kino Lorber be liable for any consequential damages. The terms and conditions of this Agreement shall apply to any replacement Program(s) furnished.
7. **RESERVATION OF RIGHTS** Legal title to the Programs shall at all times remain in Kino Lorber and all rights therein are reserved to Kino Lorber. The term "Purchase" as used herein means only the right and license for Licensor to use and resue the Programs without limitations as to the uses or reuses, but without any change in ownership or title and otherwise subject to the terms and conditions of this Agreement.
8. **DEFAULT** If Licensor defaults hereunder: (a) Kino Lorber, in addition to other remedies, may repossess any Program previously delivered hereunder; and/or (b) Kino Lorber may refuse to take any further orders from Licensor and may refuse to make further shipment of Programs to Licensor; and/or (c) Licensor agrees to pay Kino Lorber's costs and expenses of collection and/or repossession including the maximum attorney's fees allowed by law.
9. **ASSIGNMENT** This Agreement shall not be assignable by Licensor.
